

Don't Be Scammed!

Online shopping is all the rave for many, and fraudsters know that too. These swindlers know how to advertise "miracle fat loss pills", "anti-aging serums", and other nonsensical products to make an easy buck off unaware individuals. We don't want our members falling victim to these kinds of scams.

That's why, now it's more important than ever to...

- 1. Be cautious when sharing your credit card information with online merchants, or anyone for that matter.
- 2. Only transact with legitimate, well-known merchants. Refrain from clicking on those social media links that advertise free products, free trial periods, or items that seem too good to be true. Believe us when we say they probably are!
- 3. Read the fine print of all products you are initiating a purchase for because once you checkmark that "Agree to the Terms and Conditions" box, you could be authorizing more than what you think, giving scam merchants precisely what they want.

Scammers are everywhere, preying on "easy targets." Be vigilant, and if something seems like a scam, it probably is one. Visa looks out for your personal information and is dedicated to keeping it safe, but cardholders also have a duty in protecting their own sensitive information online or offline.
